**MONTHLY BUSINESS MEETING**

The regular monthly meeting of the Board of Supervisors was held at the township meeting room, beginning at 7:30 p.m. Sup. Dovin called the meeting to order and led in the pledge of allegiance to the American flag. The roll was called and all three supervisors were present.

**Presentation of minutes and treasurer’s report** – A motion was made by Sup. Doolittle and seconded by Sup. Mordovancey and unanimously carried by the board to accept the minutes and the treasurer’s report as submitted.

**Citizens Input on the Agenda** – No one had any input to share.

**Reports of the board, commissions and committees**

**Susquehanna Co. Council of Governments, C.O.G. Sewage and Codes Committees** –

Sup. Mordovancey stated that nothing was brought up that pertained to Choconut Township.

**Report of Susquehanna Co. Planning Commission Meeting** – John Ramsay reported that a meeting was not held.

**Report of Supervisors on Current Roadwork** – Many fallen trees were cleared off of roads and repairs to roads were made where necessary. Debris from flooding that took place and affected the creek behind the township garage building was cleared out, to prevent damage to the buildings from any floods that would take place in the future. Roads were plowed and cindered after the snowstorm in November.

**OLD BUSINESS**

**Violators of the Junk Yard Ordinance** – Sup. Mordovancey reported that all of the unregistered cars on the property owned by the late Donald Sechrist have been removed. The supervisors are waiting to hear back from DEP regarding the Parks property. The secretary was instructed to write a letter to Virginia Romanick about the unregistered vehicles on her property.

**NEW BUSINESS**

**Winter Maintenance Agreement with Friendsville Borough** – Chairman of the Board Sup. Dovin signed an agreement on behalf of Choconut Township with the Borough of Friendsville for the maintenance of the borough’s roads during the Winter of 2024 – 2025. Chris Snedeker, Chairman of the Council of Friendsville Borough, signed on behalf of the borough.

**Adoption of the Proposed Budget for 2025** – A motion was made by Sup. Doolittle, seconded by Sup. Mordovancey and unanimously carried by the board to grant final approval to the budget for 2025 as proposed.
